

PRIVACY POLICY

In accordance with Article 13 of Italian Legislative Decree 196/2003 and EU Regulation 2016/679 (GDPR) **ASO H&P S.r.l.** (henceforth the "Company") provides the following information with regard to the protection of users' personal data (henceforth "Data") collected through the website www.asohp.com (hereafter the "Website")

A. DATA CONTROLLER AND RESPONSIBLE FOR DATA PROTECTION

B. TYPE AND NATURE OF COLLECTED DATA

By using the Website, the user accepts that ASO may process the under-mentioned type of Data.

1) Data gained via cookies

The exploration of the Website involves the receipt of cookies. Cookies are short text strings that a Website sends to a user's browser, which are memorised to be then retransmitted to the same Website during further user's visits.

2) Data provided voluntarily by users to ask for information

The optional sending of e-mails through the section *Contacts* or directly to the addresses indicated in the Website involves the subsequent acquisition of the sender's address, needed to answer requests, as well as any other personal data in the contact form.

C. PURPOSES AND LEGAL BASIS OF DATA PROCESSING

All Data provided by the user to get information and necessary to the provision of services made available by the Company will be processed for these purposes; the legal basis of such processing is the fulfilment of a contract of which the Data subject is a party or to perform pre-contractual measures at the request of the user or legitimate interest of the Owner to provide information about the Company.

Given Data, in special cases, may also be processed to:

- fulfil any obligations under applicable laws, regulations or community legislation, or satisfy requests from the authorities. The legal basis of such processing is the obligation to comply with the binding legislation;
- enable the Data Controller to defend his rights in case of any disputes, including legal proceedings. The legal basis of such processing is the Data Controller's legitimate interest to protect his rights.

D. DATA RECIPIENTS

Data may be shared with:

- 1. subjects that typically act as Responsible for Data processing pursuant to Article 29 of the Regulation GDPR, i.e. subjects that cooperate with the Data Controller for the purposes mentioned above;
- 2. subjects, bodies or authorities to whom it is mandatory to communicate your personal data in accordance with the provisions of law or orders of the authorities;
- 3. persons authorised by the Company in accordance with Article 29 of the Regulation GDPR to the processing of Data necessary to carry out activities strictly related to the provision of the services, who have an appropriate legal obligation of confidentiality.

E. DATA TRANSFER

The Data will not be transferred outside the European Union.

F. DATA RETENTION

The Data will be stored for the time strictly necessary to achieve the purposes mentioned above, applying the principles of minimisation and proportionality. In any case:

- with reference to the provision of services, the Company will store the Data for the time strictly necessary and in any
 case no longer than the storage times allowed by Italian Law for the protection of its interests (Article 2946 Civil
 Code et seq.);
- with reference to Data processed to fulfil legal obligations, they will be stored as long as required by the specific obligation or applicable law;
- with reference to Data processed for the defense of the Controller's rights, no longer than the storage times allowed by Italian Law for the protection of his interests.

G. RIGHTS OF DATA SUBJECTS

Pursuant to Article 15 of the Regulation GDPR et seq., the Data subject has the right to ask the Company to access to, rectify or erase his personal Data or raise an objection against their processing, to request for restriction of processing in the cases provided for by Article 18 of the Regulation GDPR, as well as obtain them in a structured, commonly used and device-readable format, in the cases provided for by Article 20 of the Regulation.

Requests should be addressed in writing to the Company at the above-mentioned addresses.

In any case, the Data subject is always entitled to lodge a complaint with the competent supervisory authority, i.e. the Italian Data Protection Authority, according to Article 77 of the Regulation GDPR, where it is considered that the processing of Data is contrary to the legislation in force.
